

**Minutes of a Special Session of a Special Meeting and Possible Executive Session of the

CALL TO ORDER - Meeting was called to order at 2:06 PM by Jim Elmer.

David Gordon moved to nominate Jim Elmer as Chairperson. Allen Vigneron seconded the motion. The motion was approved unanimously.

Allen Vigneron moved to adjourn to Executive Session per A.R.S. Section 38-431.03.A.3. David Gordon seconded the motion. The motion was approved unanimously.
