AGENDA ITEM: ADJOURNMENT:

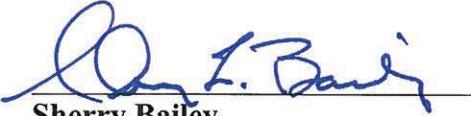
