Background: Vice Mayor Jerry Wiley is the Town's current representative to NACOG. With the expiration of the Vice Mayor's term in office in June, we will need a new representative to NACOG. Vice Mayor Wiley has asked that we take action to appoint a new NACOG representative at this time, so that the new representative can attend the April 22nd NACOG Board meeting with Vice Mayor Wiley, in order to make a smooth transition.

Although the appointment would be made now, the staff recommends that the appointment be effective June 8, 2010, to coincide with the expiration of Vice Mayor Wiley's term in office.

Town Staff has explained the process for appointing Council Members to the various regional groups to Councilmember-Elect Regner, and he understands that he might be asked to serve in such a capacity. He has indicated that he would be willing to serve in the NACOG role if there is no existing Council Member who would prefer to do so.

Recommendation: Staff recommends that the Council approve Resolution #1331, the appointment of an existing Council Member or Council Member-Elect Bill Regner to replace Jerry Wiley as Clarkdale's representative to NACOG, effective June 8, 2010.

RESOLUTION # 1331

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CLARKDALE, ARIZONA, APPOINTING THE TOWN OF CLARKDALE'S REPRESENTATIVE TO THE NORTHERN ARIZONA COUNCIL OF GOVERNMENTS (NACOG).

WHEREAS, there are regional organizations the Town of Clarkdale associate with and serve on;

WHEREAS, the Vice Mayor Jerry Wiley is the current representative of the Town of Clarkdale serving on the Northern Arizona Council of Governments (NACOG), whose term will expire on June 8, 2010; and

WHEREAS, the Town of Clarkdale Mayor and Common Council are requested to notify these organizations who is appointed as official Town of Clarkdale representative.

NOW, THEREFORE, BE IT RESOLVED THAT the Mayor and Common Council of the Town of Clarkdale authorize _____ as the official Town of Clarkdale representative to serve on the Northern Arizona Council of Governments (NACOG) effective June 8, 2010 to June 30, 2012.
