PARADE ENTRY FORM

Parade Rules:

Parade entrants limited to children eighteen (18) years and under. Children ages six (6) years and under must be accompanied by one (1) adult or another child at least thirteen (13) years of age.

Pets: Entries with animals are limited to household pets only, weighing no more than 50 lbs. No hooved animals are allowed. Entries with dogs must have proof of a current license. All pets must be on leashes and must be held by someone strong enough to manage them. All pets participating in the parade must be kept under control at all times. Participant is responsible for pet clean-up.

A Waiver of Liability Form for each participant under the age of eighteen (18) years **MUST** be completed and signed by a parent/legal guardian of the minor to participate in the parade.

Helmets and safety gear are strongly recommended for children riding bicycles, skateboards, and scooters.

No Commercial entries.

No gas powered vehicles will be allowed.

Candy & giveaways must be handed out to observers, not thrown.

Participants are limited to win one prize and cannot win in more than one category.

TOWN OF CLARKDALE RELEASE AGREEMENT IN CONSIDERATION OF BEING PERMITTED TO PARTICIPATE OR USE OF ANY TOWN FACILITIES IN CONNECTION WITH THIS ACTIVITY, THE UNDERSIGNED AGREES TO THE FOLLOWING:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND RELINQUISHES THE TOWN OF CLARKDALE, ITS EMPLOYEES, OFFICERS, AGENTS, AND INDEPENDENT CONTRACTORS (hereinafter referred to as "releasees") from all liability to the undersigned, his or her personal representatives, assigns, heirs, and next of kin for any loss, damage, or claim thereto on account of injury to the person or property of the undersigned, whether caused by any negligent act or omission of the releasees or otherwise while the undersigned is participating in a Town activity or using any Town facilities in connection with the activity.

2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS THE TOWN OF CLARKDALE, ITS EMPLOYEES, OFFICERS, AGENTS, INDEPENDENT CONTRACTORS, AND VOLUNTEERS from all liability, claims, demands, causes of action, charges, expenses, and attorney fees (including attorney fees to establish the releasees right to indemnity or incurred on appeal) resulting from involvement in this activity whether caused by any negligent act or omission of the releasees or otherwise.

3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE while upon Town property or participating in the activity or using any Town facilities and equipment whether caused by any negligent act or omission of releasees or otherwise. The undersigned expressly agrees that the foregoing release and waiver, indemnity agreement and assumption of risk are intended to be as broad and inclusive as permitted by Arizona law and that if any portion thereof be held invalid, notwithstanding, the balance shall continue in full legal force and effect.

THE UNDERSIGNED ACKNOWLEDGES THAT HE/SHE HAS READ THE FOREGOING and is fully and completely aware of the legal consequences of this agreement, including that it prevents the undersigned from suing the Town, or its employees, officers, agents, independent contractors, or volunteers if participant is injured or damaged for any reason as a result of participation in this activity. The undersigned further acknowledges that no oral representations, statements or inducements have been made.

THE UNDERSIGNED ACKNOWLEDGES THAT HE/SHE HAS READ THE PARADE RULES and agrees to abide by all parade rules set forth.

PHOTOS/VIDEOS RELEASE FOR ALL PARTICIPANTS: I grant full permission for the Town of Clarkdale to use photos or videos (electronic, film or digital) taken of the participant(s) in which participant(s) may appear to be used for any purpose, including publicity and commercial marketing and advertisement by the Town of Clarkdale and this agreement evidences my consent to such uses.
